Application for an Order under sections 1 and 5 of the Transport and Works Act 1992

On behalf of the Vale of Rheidol Railway Limited (the VOR) we hereby apply for an Order under sections 1 and 5 of the Transport and Works Act 1992 in the terms of the draft Order accompanying this application.

The Order would provide statutory authority for the VOR to maintain and operate the railway authorised by the Brecon Mountain Railway (Light Railway) Order 1980 (the Original Order).

The Order also seeks to provide clarity of the powers granted under the Original Order by omitting some of the consent provisions contained in the Original Order in recognition that the railway is now a fully operational railway and no further construction is contemplated.

The Order would further provide for the VOR and any subsequent railway undertakers to sell or lease all or part of the railway and, on so doing, to transfer their statutory rights and liabilities relating to it to the transferee by agreement between the undertaker and the transferee and with the consent of the Welsh Ministers, but without the need for a further statutory instrument.

In addition, the Order would provide the undertaker with the flexibility to operate the railway using additional forms of motive power that were not available when the Original Order was granted.

The Order does not authorise the construction of any works or the acquisition of land.
